- 3 The Company operates in a single segment of manufacturing and selling of foundry machinery and machinery parts.
- 4 Effective April 1, 2018 the company adopted Ind AS 115 using cumulative effect method. The standard is applied retrospectively only to contracts that are not completed as at the date of initial application and the comparative information is not restated in the results. The adaption of the standard did not have any material impact on these financial results.
- 5 The Government of India introduced the Goods and Services Tax (GST) with effect from July 01, 2017. GST is collected on behalf of the Government and no economic benefit flows to the entity, consequently revenue for the quarter December 31, 2018, September 30, 2018 and December 31, 2017, nine months ended December 31, 2018 and December 31, 2017 and for the year ended March 31, 2018 are presented net of GST. Accordingly, the gross revenue from operations figures for the year to date figures are not comparable with the previous periods presented in the results.
